# Pistor Dress Code

The Pistor Middle School Dress Code is designed to promote student health, school safety, and conditions conducive to learning. Pistor Middle School students are career and college-bound scholars; we dress for success!

## Top Garment:

- □ Plain, solid colored shirt in red, black, white, or gray. No logos or print of any kind.
- □ Shoulders and midriff must be covered. No tank tops, spaghetti straps, crop tops, etc.

### **Bottom Garment:**

- □ Jeans, pants, shorts, or skirts in solid black, blue, or khaki. No rips, holes, tears, or fraying.
- Bottom garment must fit at the waist no sagging.
- Sweatpants, pajama pants, leggings, bicycle shorts, etc. are not allowed.

#### Shoes:

- □ Athletic shoes, sneakers, or sandals in any color.
- □ Crocs, slides, slippers, flip flops, etc. are not allowed.

#### Outerwear:

- □ Jackets, pullovers, hoodies in any color. No logos or print larger than a tennis ball or that promote drug and/or alcohol use, violence, or sexually explicit content.
- □ Hats, hoodies, and sunglasses must be taken off inside the building and classrooms.
- □ Students are required to wear a top garment under their outerwear garment.

### School IDs:

Students are required to wear school IDs. IDs must be visible throughout the school day. The first ID is free. Subsequent IDs will cost \$3.00 and charged to the student account payable no later than the end of the school year.

### **Dress Code Violations :**

Dress code sweeps will be conducted on a regular basis to ensure that the Pistor Middle School Dress Code policy is being observed by students.

### **Initial Violation:**

- **Notification:** If a dress code violation is observed, the student will be discreetly informed of the infraction.
- □ **Correction:** The student will be given an opportunity to correct the violation immediately. This may involve adjusting their attire or using school provided alternatives. Parents/guardians will be asked to bring a change of clothing to school if the student cannot correct the violation with provided alternatives.

### **Repeated Violations:**

- □ **Notification and Correction:** If a student violates the dress code again, they will follow the same procedure as the initial violation.
- □ **Parent/Guardian Involvement:** Additionally, a notification will be sent home to parents/guardians informing them of the repeated infraction.

### **Chronic Violations:**

- □ **Notification and Correction:** If a student continues to violate the dress code despite previous interventions, they will follow the same procedure as the initial violation.
- Parent/Guardian Involvement: Additionally, a meeting will be arranged with the student, their parents/guardians, and a school administrator to discuss the recurring issue. The goal of the meeting is to understand any underlying reasons for the dress code violations and to develop a plan to ensure future compliance. The student may be placed on a behavioral contract, outlining specific expectations and consequences for further violations.
